UD-1 diversion was stable and functional.

**4.c Hydrologic Balance: Other Sediment Control Measures**

Silt fences below the A-seam slope were functioning as designed. Soils were moist in front of the fences due to rains two days previous. However, no water was impounded.

**13. Revegetation**

Collected a handful of seed from the access road and scatter it along the UD-1 ditch on A seam side.

**16.b Roads: Drainage Controls**

Recent work on the access road drainage maintained its integrity through the recent storms. No cutting or gullying evidence seen. Berms were stable.
