2. Signs and Markers

The mine identification sign was observed at the end of the county road and the entrance into the permit area. The sign contains the required information by regulation.

4.c Hydrologic Balance: Other Sediment Control Measures

The silt fence that is in close proximity to the mine identification sign is in place and is functional. The fence is sagging and needs to be re-tensioned and secured to prevent it from wind damage and failure.
