2. Signs and Markers

The mine identification sign is had constructed and has been shot through several times. The sign is still legible and does contain all of the required information required by regulation. The sign is located at the end of the county road and at an access point into the permit area.

4.a Hydrologic Balance: Diversions

One main diversion is located along side of an old access road down into the area where the reclaimed portal area lies. The diversion is functional.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

No sediment ponds on site.

4.c Hydrologic Balance: Other Sediment Control Measures

A silt fence is located adjacent to the mine identification sign. The silt fence is functional.

4.e Hydrologic Balance: Effluent Limitations

No effluent discharges occur at this site in its current state.
