2. Signs and Markers

Observed the mine identification sign that is placed at the end of the county road and the entrance into the mining permit area. The sign is constructed of a piece of metal that has a white background and has the company name, address, telephone number, and mining permit number. This information is scribed onto the metal sign with a magic marker. The sign meets the requirements of the Utah R645 Coal Rules and was therefore found to be compliant.

4.a Hydrologic Balance: Diversions

Observed the road diversion from the precipice above. The diversion appears to be functional.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

No sediment ponds within this mine site.

4.c Hydrologic Balance: Other Sediment Control Measures

The silt fence that is located near the mine identification site was observed during the inspection. The silt fence is functional.
