2. Signs and Markers

The mine identification sign was observed at the end of the county road road used to access the Hidden Valley Mine site. The sign is placed at the entrance into the permit area from the public road. The sign was inspected and found to contain the name, address, phone number and Utah Mining Permit Number of the operator. The sign was deemed compliant with the Utah R645 Coal mining requirements specific to mine identification signs.

The main diversion and channels were functional at the time of the inspection.

The only silt fence on the mine site that is located adjacent to the mine identification sign was inspected and found to be functional.
