

The mine identification sign was observed at the end of the county road used to access the Hidden Valley Mine site. The sign is placed at the entrance into the permit area from the public road. The sign was inspected and found to contain the name, address, phone number and Utah Mining Permit Number of the operator. The sign was deemed compliant with the Utah R645 Coal mining requirements specific to mine identification signs.
