The mine identification sign is in place at a point of public access into the mining permit area. The sign contained all of the required information. The sign has faded and the writing needs to be darkened. The sign can still be read if you get out of the vehicle and walk up to it. 4.c Hydrologic Balance: Other Sediment Control Measures

The siltation fence that is located near to the mine identification sign was physically inspected and found to be functional. A picture of the siltation fence was taken and is attached to the PDF version of this inspection report. There are two layer of silt fence in portions of the structure. This appears to have come about as part of a repair of a ripped portion
