2. Signs and Markers

The mine identification sign is posted at the end of the county road just prior to entering the mining permit area for the Hidden Valley Mine Site, Utah Mining Permit Number C/015/0007. The sign is hand written and contains several bullet holes, but is still legible. The sign does list the company name, address, phone number and mining permit number in accordance with the requires found in the Utah R645 Coal Rules.

4.c Hydrologic Balance: Other Sediment Control Measures

The Hidden Valley Mine has on Alternate Sediment Control Area, ASCA, with in the mining permit area. The ASCA is located near the mine identification sign. The ASCA is treated by a siltation Fence. The silt fence was inspected and found to be functional.
