2. Signs and Markers

The mine identification sign is posted at the entrance into the mining permit area. The sign shows the name, address, phone number and mining permit number as required by regulation. The sign is compliant.

4.c Hydrologic Balance: Other Sediment Control Measures

One siltation structure is present on the mine site. This structure is a siltation fence which is placed in close proximity to the mine identification sign. The structure has had recent maintenance done by re-securing the top of the structure using zip ties. This sediment control measure is functioning properly and well maintained.
