2. Signs and Markers

The mine identification sign is in place at the end of the county road and the beginning of the mining permit area. The sign contains the address, name, phone number and mining permit number of the operator as required by law. The mine identification sign is compliant.

There is one siltation fence located within the permit area. The location of this siltation fence is near or adjacent to the mine identification sign. The siltation fence was examined during the partial inspection and was found to be fully functional.
