**2. Signs and Markers**

The mine identification sign is clearly posted at the end of the county road and the beginning of the mining permit area. The sign lists the company name, address, phone number and mining permit number as required by regulation.

**4.c Hydrologic Balance: Other Sediment Control Measures**

The only alternate sediment control is a silt fence that is located adjacent to the mine identification sign. The silt fence is well maintained and functional.
