2. Signs and Markers

The mine identification sign is a small manmade sign that contains the name of the company, address, phone number and mining permit number. This sign is posted at the end of the county road and entrance into the Hidden Valley mining permit area.

4.a Hydrologic Balance: Diversions

Area is covered by a blanket of snow. It was snowing during the inspection.
Diversion is not visible do to the storm

4.c Hydrologic Balance: Other Sediment Control Measures

One alternate sediment control structure is present on site. This structure is a siltation fence that is located in close proximity to the mine identification sign. Portions of the silt fence toward the top are becoming frayed. The silt fence is still fully functional, but should be monitored as to ensure that it does not de-grade to the point that it is no longer functional.
