2. Signs and Markers

The mine identification sign is placed at the end of the county road used to access the mine. The sign is located at the entrance point into the mining permit area. Contents of the sign include the name, address, phone number and Utah Mining Permit number as is required by statute. The sign was found to be in compliance with the regulation requirements.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

No sediment ponds are currently associated with this mining permit.

4.c Hydrologic Balance: Other Sediment Control Measures

One alternate sediment control structure is associated with this permit. This alternate sediment control is a siltation fence. This siltation fence is located near or adjacent to the mine identification sign. The siltation fence was checked during the partial inspection and was found to be well maintained.

5. Explosives

No explosives are stored or maintained at this mine site.

7. Coal Mine Waste, Refuse Piles, Impoundments

No refuse pile or waste rock site is associated with this mining permit.

8. Noncoal Waste

The mine site was free of noncoal waste items.
