The mine identification sign is present at the entrance into the mining permit area. The new sign identifies Bronco as the operator/owner with their address, phone number and mining permit number as required by law. The sign is compliant. All discharge monitoring reporting was suspended on October 1, 2016, since no discharges have occurred or no structures to discharge from. A permit is still in place.
