The mine identification sign is clearly posted at the entrance into the mining permit area. The sign does contain the name, address, phone number and mining permit number as required by law. The top of the sign is missing bolts to secure the sign. Arrangements was made with mine personnel to re-attach the sign to prevent loss or damage.

There are no sediment ponds on site.

The only siltation fence on site is located near to the mine identification sign. The silt fence is functional.
