

In reference to State Notice of Violation #8, Rule MC 717.20(b) issued during the June 5, 1980 inspection of the Trail Mountain Mine, the Division hereby directs the Trail Mountain Mine to revegetate all areas no longer used for mining by no later than October 20, 1980. Failure to comply with said directive will result in a mandatory \$750.00 per day fine for each day the violation is unabated as described in Section 40-10-20(8) of Chapter 10 of Title 40, Utah Code Annotated, 1953.
