General Comments. The mine is now producing coal even though all the reconstruction has not been completed. The only major item appears completing the tipple and moreover, that position that will interface with the Cottonwood beltline line and associated facilities Sediment Pond. The sediment pond contained runoff and was not discharging. The pond was covered with ice.

Disposal Of Excess Spoil. A small amount of spoil material generated in connection with the reconstruction still remains on site. None of the material was being transported to the waste rock site during the inspection.

New Coal Waste. New coal waste was stored in dumpsters located near the sediment ponds.

The former pit storage area has now been reclaimed.

Roads Roads were recently graded. Drainage conforms to the design as shown on the 'as built drawings'.

Roads will be used for coal haulage until such time that the coal beltline between Trail Mt Mine and the Cottonwood is approved, constructed and in operation.
