4A. HYDROLOGIC BALANCE: DIVERSIONS

Two undisturbed culverted diversions are in place. Cottonwood Creek is the only perennial diversion. There is one undisturbed concrete diversion that collects and routes runoff to the sediment pond. The culverts and concrete ditch were functional. Water was reporting to the concrete ditch from the tipple wash process.

4B. HYDROLOGIC BALANCE: SEDIMENT PONDS AND IMPOUNDMENTS

The sediment pond lies immediately below the mine site. This provides the sediment control for the majority of the disturbed area. The pond was cleaned last fall.

The sediment pond was not discharging; no hazardous conditions were noted during the inspection.

4C. HYDROLOGIC BALANCE: OTHER SEDIMENT CONTROL MEASURES

There are two BTCA areas; one is located above the parking lot. The other lies below the sediment pond. Both appeared to be functioning as designed.

8. NONCOAL WASTE

All noncoal waste which is generated by the operational stage is temporarily stored on the surface. It is permanently disposed of at a land fill. A used oil container is adjacent to the fuel storage within a concrete containment structure.

Some litter was observed in the parking lot. It will be removed by the permittee.

18. SUPPORT FACILITIES/UTILITY INSTALLATIONS

No new support facilities have been permitted for the mine site.
