PacifiCorp, by and through its wholly-owned subsidiary, Energy West Mining Company ("Energy West") as mine operator, hereby submits updated information for the supplemental volume entitled "Supplemental Volume, Legal and Financial Information". This information is in response to the deficiencies that were received from the Division on December 29, 2004. The following responses to deficiencies are formatted as found in the technical analysis document. They are broken down into logical section headings similar to the R645 regulations. R645-301-301-114, The Permittee needs to update the Underground Right-of-Entry Information with Cited Surface and Subsurface Ownership information in Appendix C of the Legal and Financial Volume to include the February and June 2004 lease relinquishments.

Appendix C in the Supplemental Volume, Legal and Financial Information has been updated to include all current Underground Right of Entry Information. This submittal includes a completely reformatted table. The table is in an Excel format to provide a more accurate accounting of acreages. We hope this format will be easier for the Division to review.
