1. Permits, Change, Transfer, Renewal, Sale

Mr. Oakley and I discussed how the sale of the Trail Mountain Mine (including the Waste Rock Site) is anticipated to be 6/5/15. The Division should anticipate applications from Energy West Mine and Bowie Resources regarding the change of ownership.

2. Signs and Markers

The sign at the waste rock site contains all the required information.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Due to recent rain storms, there is a small amount of water in the waste rock site sediment pond. The pond was cleaned in April 2015 and is well below the 60% design storage capacity. 60% design is 6763.6 ft (1.45 AF) and current level is 6762.8 ft (1.31 AF).

4.c Hydrologic Balance: Other Sediment Control Measures

Walked top-soil piles #1 and #2. The waddles and silt fence are retaining the top soil on the pile as designed. They were recently maintained by manually digging out the sediment that had filled up next to waddles to prevent spill-over.
