

1. Permits, Change, Transfer, Renewal, Sale

The permit was transferred to Fossil Rock Resources on October 8, 2015.

2. Signs and Markers

Signage was present and up to date at both the waste rock site and mine site.

4.a Hydrologic Balance: Diversions

Diversions appeared to be in good working order. All runoff will be properly conveyed to the sediment ponds at both the waste rock site and mine site.

4.e Hydrologic Balance: Effluent Limitations

Discharge Monitoring Reports show there has been no flow from the two outfalls.

21. Bonding and Insurance

The Certificate of Liability insurance will expire on Feb. 2nd, 2016. The insurance covers explosives.

The mine is bonded under a surety bond for \$1,154,000.
