3. Topsoil

Topsoil and subsoil covers the southern outslope face of the lifts. The remaining of the first lift has progressed to its southern end where operations are recovering this topsoil and subsoil off the face (Photos 1-2). A sediment fence has been installed on the face of the southern lift below the operations to catch any topsoil or subsoil that may migrate downslope during operations.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

A valve has been installed at the outlet of the decant pipe for the waste rock pond (Photo 4). This will be very useful for controlling the water level in the waste rock pond.
