3. Topsoil

The small pile of salvaged material from the face of the lifts was determined to be subsoil. This pile will be placed on the northern end of the subsoil pile and stabilized.

The topsoil has eroded off the face of the reclaimed lift. Subsoil is the only material that remains. When the face of the lifts are salvaged for material the subsoil will be placed on the northern end of the subsoil pile.

It was discussed if the salvaged and newly placed subsoil will be kept on the subsoil pile long term, the placed material should be stabilized by pocking and/or seeding the material.

4.c Hydrologic Balance: Other Sediment Control Measures

The gully on the eastern slope of the subsoil pile should be stabilized before it enlarges.

18. Support Facilities, Utility Installations

Fuel containment is in place for the onsite diesel tank.
