2. Signs and Markers

A sign indicating the name, permit number, and other contact information is posted in plain view at the waste rock site.

3. Topsoil

Topsoil piles at the waste rock site are completely covered over with approximately 6 - 8 inches of encrusted snow. There is very little activity at the site as evidenced by the lack of fresh tracks in the snow.

15. Cessation of Operations

Mine is currently in cessation.
