1. Permits, Change, Transfer, Renewal, Sale

The permittee is in the process of receiving approval from the Division to add additional permit area. The additional permit area is needed to revamp the surface facilities to control coal dust. The amendment is expected to be approved in January.

2. Signs and Markers

The permittee has been requested to paint the disturbed area markers in the spring of this year. Some of the markers have faded and are difficult to see.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile was inspected with no hazardous conditions noticed. The outslopes of the pile have been graded to 2:1.

8. Noncoal Waste

The mine site was clear of non-coal waste material.

15. Cessation of Operations

The mine has not produced any coal since the middle of August of 2003. However, the mine is crushing and screening the coal and selling the coal on the open market. The mine is not considered as being in temporary cessation.

18. Support Facilities, Utility Installations

The permittee is drilling holes in the ground around the coal stockpile at the 4th East portals. This is to make footers for the installation of the wind fence. Some electronic gear for water sprays have been installed. The cattle guards to clean truck tires have been installed after the coal loading process. The permittee has installed an additional cattle guard to the entrance to the 4th East Portals.
