1. Permits, Change, Transfer, Renewal, Sale

The permittee was in the process of installing wind fence screens to the poles at the 4th East portals. Water sprays and truck wheel cleaner are constructed. The permittee has not yet received the coal crusher at the mine site. The water canons are in the warehouse. The construction of the new truck road is scheduled to begin in two weeks.

3. Topsoil

The topsoil piles are uncovered from the snow. There were no signs of wind or water erosion.

4.a Hydrologic Balance: Diversions

The diversions were spot-checked through the property. Some of the diversions did contain water and were functioning as designed.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Sediment ponds were inspected with no hazardous conditions noticed during the inspection. Some of the ponds did contain water. Ducks and geese were on the mine water ponds.

8. Noncoal Waste

The permittee has been told that the 4th East portal area needs to be cleaned up from non-coal waste material, since the snow melt has uncovered some non-coal waste material.

15. Cessation of Operations

The permittee was in the process of submitting information to headquarters needed to re-open the Emery Deep Mine.

16.a Roads: Construction, Maintenance, Surfacing

The permittee plans to begin construction of the coal yard bypass road for coal trucks within the next two weeks.

18. Support Facilities, Utility Installations

The permittee was in the process of installing wind screens on the wind poles.
