13. Revegetation

Possible reclamation sites include reverse osmosis pond and pump site #3 that are south and north, respectively, of the county road leading to 4th east portal. There was a third possible site between the fan and transformer station at the main mine site. This site was eliminated because of possible cover from the 4th east portal would confound the results of the intent of this phase of the vegetation project. Priscilla Burton will make the final decision for the appropriateness of this third site. There were no final decisions about any of the sites, but the Permittee is considering revegetating the two sites with the goal of final reclamation. If vegetation efforts are successful, then these areas might be eligible for bond release review. If efforts are not successful, the Permittee understands that implementation of additional revegetation procedures will be required.
