

1. Permits, Change, Transfer, Renewal, Sale

The permittee plans to submit an amendment to the Division requesting to do full extraction underground. The permittee has submitted a room and pillar plan to MSHA.

2. Signs and Markers

The permittee has identification signs posted on gates entering the permit area from public roads. Information is correct and complies with the requirements of the R645 Coal Rules.

3. Topsoil

The topsoil piles were snow covered. There were no signs of erosion on the topsoil piles.

4.a Hydrologic Balance: Diversions

The diversions at the 4th East Portals were inspected and complied with the performance standards.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The 4th east Portal sediment pond did contain water but was not discharging during the inspection. No hazardous conditions were noticed during the inspection.

4.d Hydrologic Balance: Water Monitoring

The permittee was advised to submit water monitoring information for the third quarter by the end of the year.

7. Coal Mine Waste, Refuse Piles, Impoundments

I inspected the refuse pile with no hazardous conditions noticed during the inspection. However, I requested that the permittee remove some trash (non-coal waste) from and within the pile.

8. Noncoal Waste

Several areas throughout the property had non-coal waste material. I requested the permittee to remove the material.

18. Support Facilities, Utility Installations

No additional support facilities were constructed since the last inspection.
