The permittee has submitted an amendment to change the partial pillar removal plan in the MRP. This amendment is under review by the Division and has been approved by MSHA.

3. Topsoil

Topsoil piles are covered with snow.

4.a Hydrologic Balance: Diversions

The diversions were spot-checked and were functioning as designed.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The 4th East portal sediment pond was inspected and was retaining water as designed. No hazardous conditions were noticed during the inspection of the sediment pond.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile was inspected with no hazardous conditions noticed during the inspection.

8. Noncoal Waste

The mine site was generally clear of non-coal waste material.

No additional support facilities were installed since the last inspection.
