2. Signs and Markers

The identification sign at the 4th East Portals has been installed since the last inspection. The information is correct. The permittee had an ID sign but ended up missing prior to last month's inspection.

3. Topsoil

The topsoil piles were inspected and there were no signs of wind or water erosion.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond was inspected at the 4th East portals. It contained water and was close to the discharge level. I found out the water was being pumped from underground.

7. Coal Mine Waste, Refuse Piles, Impoundments

A small amount of refuse material was at the 4th east portals. This material will need to be shipped to the main refuse pile.

8. Noncoal Waste

The non-coal waste material was cleaned up since the last inspection.
