1. Permits, Change, Transfer, Renewal, Sale

The permittee has no amendments submitted to the Division.

2. Signs and Markers

Signs and markers were inspected and complied with the requirements of the R645 Coal Rules.

3. Topsoil

Topsoil piles were inspected with no signs of wind or water erosion.

4.a Hydrologic Balance: Diversions

Diversions were inspected and were functioning as designed.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment ponds were inspected with no signs of hazardous conditions. The 4th east portal sediment pond did contain water but was not discharging during the inspection. The permittee did take the third quarter sediment pond inspection. No hazardous conditions were reported.

7. Coal Mine Waste, Refuse Piles, Impoundments

The permittee will need to move the refuse at the 4th east portals. The permittee stated the material will be moved.

8. Noncoal Waste

The mine site was clear of non-coal waste material.

18. Support Facilities, Utility Installations

No new support facilities have been constructed since the last inspection.
