1. Permits, Change, Transfer, Renewal, Sale

The mine had miner's vacation. The permittee was changing out a section of the conveyor system. No amendment is required since it is a change out and bonding will not change.

2. Signs and Markers

Signs and markers were inspected and complied with the requirements of the R645 Coal Rules.

3. Topsoil

I inspected the refuse pile and found no signs of wind or water erosion.

4.a Hydrologic Balance: Diversions

Diversions were spot-inspected and would function during a storm event.

4.d Hydrologic Balance: Water Monitoring

The permittee was in the process of taking water samples.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile was inspected and no hazardous conditions were noticed during the inspection.

8. Noncoal Waste

The mine site was clear of non-coal waste material.

14. Subsidence Control

Surveyors were installing new survey points for subsidence.
