Dear Mrs. Grubaugh-Littig:

Please consider this a re-submittal of Consol's full extraction amendment to the Mine Reclamation Plan for the Emery Mine.

Consol submitted for full extraction over the above mentioned panels in July 2006. At that time it was decided that the PHC and the R2P2 needed to be revised, prior to approving the full extraction. Now that the revised PHC was approved on March 16, 2007 and the revised Resource Recover and Protection Plan was approved by BLM on January 17, 2007, Consol is resubmitting the full extraction package.


Per the ongoing expansion of the Emery Mine, Consol plans to increase the resource recovery by utilizing a pillar splitting plan that would fall into the planned subsidence category. This plan is for the 4th East submains, the 14th and 15th West panels, and the 6th West panel. Consol will obtain MSHA approval prior to commencing pillar splitting. As can be seen from the figures, no pillar splitting will occur within the Christiansen Wash Buffer Zone.

The archeology and SHPO concurrence for these areas has been completed under the previously approved Federal IBC.

Chapter VIII, Appendix VIII-3 and Chapter IX, Appendix IX-3 will be submitted as additional information later this week when complete. These two appendices are the Vegetation and Wildlife reports prepared by Mt. Nebo Scientific.


