4.d Hydrologic Balance: Water Monitoring

Fourth quarter 2006 water monitoring is in the EDI website and has been uploaded. Water monitoring is current.

7. Coal Mine Waste, Refuse Piles, Impoundments

The area where the underground development waste or refuse is stored contains a sign that lists the area as a refuse pile. However, confusion exists in the MRP as this location is listed as a temporary storage area for underground development waste. Further research needs to be done within the MRP to insure that the material is being stored and is in compliance with the Coal Rules. Consol is researching their records to see if any clarification can be given. The lack of further clarification to show compliance could result in enforcement action. Contact with MSHA Sub District Manager Ted Farmer indicates that this is classified as a permanent refuse pile (1211-UT-09-00079-01). MSHA does not have any provisions for "Temporary Refuse Piles". MSHA plans to conduct a separate investigation and site visit.
