2. Signs and Markers

The mine ID signs are in place and contain the required information.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond at the 4th east portal area now has delimiter markers to prevent material or equipment from being placed in the sediment pond.

4.d Hydrologic Balance: Water Monitoring

Third quarter 2007 water monitoring information is in the EDI website and has been uploaded. Water monitoring is current.

18. Support Facilities, Utility Installations

A temporary pressure washing building has been placed at the 4th east portal site. This structure needs to be added to the surface facilities map and make sure that proof of adequate bond is in place, then submitted to the Division, if the operator plans to leave this in place for a duration of six months or more.
