**SUMMARY:**

On April 20, 2007 the Division received an application from Consolidation Coal Company to complete secondary or full extraction in panel 14 West. The panel can be located on the Walker Flat 7.5 minuet quadrangle map. The project is intended to facilitate the uninterrupted mining and maximum recovery of the coal. There is no anticipated surface disturbance associated with this amendment. This memo will address the Biology, Cultural Resource and Land use sections of the regulations.

Vegetative communities include greasewood, shadscale, Saltgrass, Tamarisk, Cattail/Saltgrass, Mat Saltbush, Greasewood /Tamarisk, Baren ground, Dry pasture and Irrigated pasture. A current list of threatened and endangered species is also included in the appendix along with a vegetation map of the 14 and 15 West panel areas. Plate VIII-1 has been updated to include a reference, (Appendix VIII-3 figures 1 and 2), to the detailed vegetative communities in panels 4 East, 6 West and 14 and 15 West.

**Findings:**

The information in the application is adequate to meet the requirements of this section of the regulations.

**FISH AND WILDLIFE RESOURCE INFORMATION**

Regulatory Reference: 30 CFR 784.21; R645-301-322.

**Analysis:**

A reference to the wildlife resources within the 14<sup>th</sup> West panel area has been included in the chapter nine of the MRP. A reference to the current list of threatened and endangered species is also included in the application as noted in the table of contents for chapter nine. Plate 10-1 has been updated to include the location of the 14<sup>th</sup> West panel, the panel includes elk substantial value winter habitat and substantial deer year long habitat.

**Findings:**

The information in the application is adequate to meet the requirements of this section of the regulations.

**Analysis:**

**Archeological Site Maps**

Plate X.A-1, Permit Area Cultural Resources includes the location and identification of the eight sites identified in the cultural resources inventory dated February 14, 2007. Three of these cultural resource sites, (42EM 3833, 34 and 35), are located in panels 14 and 15 west as shown on Plate X.A-1.

**Cultural Resource Maps**

Plate X.A-1, Permit Area Cultural Resources includes the proposed 14 and 15 West panels. The Plate also includes the location and identification of the eight sites identified in the cultural resources inventory dated February 14, 2007, (same requirement for Archaeological site maps).

**Surface and Subsurface Ownership Maps**

Surface ownership maps have been included in the 14<sup>th</sup> West application.

**Findings:**

The information in the application is adequate to meet the requirements of this section of the regulations.

**Protection and Enhancement Plan**

DOGM management has determined that the requirements of this section of the regulations do not apply to the information provided in the 14<sup>th</sup> West application.

**Endangered and Threatened Species**

Threatened and Endangered plant species for Emery County are listed on page 6 of Appendix VIII-3. No T&E plant species were found within the study area. As well the habitat assessment suggested almost no chance of species occurrence at the sites. In addition a sensitive species inventory of the area is also being conducted. The location of the study area is identified on the Vegetation maps, figures 1 and 2.

Threatened and Endangered animal species for Emery County have been included in the application for the 14<sup>th</sup> West panel. Calculations for mine water discharge for the 14<sup>th</sup> West panel has been included in the MRP.

**Bald and Golden Eagles**

Bald Eagles do not nest in the area but are typically inhabitants during migration. The applicant needs to address this section of the regulations. A current legible raptor survey will be submitted when completed in June of 2007.

**Wetlands and Habitats of Unusually High Value for Fish and Wildlife**

DOGM management has determined that the requirements of these sections of the regulations do not apply to the information provided in the 14<sup>th</sup> West application.

**Findings:**

The information in the application is adequate to meet the requirements of this section of the regulations.

The requirement for a protection and enhancement plan does not apply to the 14<sup>th</sup> West panel area.

Threatened and Endangered animal species for Emery County have not been included in the application for the 14<sup>th</sup> West panel.

Calculations for mine water discharge for the 14<sup>th</sup> west panel have not been included in the application.

A current legible raptor survey will be submitted when completed in June of 2007.

The requirement to include a mitigation plan for habitats of high value for fish and wildlife does not apply to the 14<sup>th</sup> West panel area.

**RECOMMENDATIONS:**

The application is recommended for approval.
