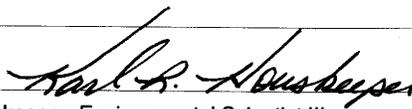

18. Support Facilities, Utility Installations

Citation 10027 was issued for " Failure to obtain a permit prior to mining and reclamation activities". The operator/permittee submitted a permit amendment to pour a concrete pad for a training tent, but started construction activities before the Division completed it's review or granted approval. The construction activities consisted of installing concrete forms and mesh support for the concrete pad. The abatement date is September 15, 2008 to receive approval. The pad site is the disturbed area, topsoil had already been stripped as part of the original mine plan and drainage reports to a sediment pond.
