**1. Permits, Change, Transfer, Renewal, Sale**

Permit Conditions: Emery Deep has one permit condition. The permittee must submit water quality data in an electronic format through the Electronic Data Input web site. This condition is being met.

**4.a Hydrologic Balance: Diversions**

The diversion referenced in the September 9, 2008 inspection report indicated that equipment and material was parked or stored within the diversion. The equipment was removed prior to the inspection conducted on October 7, 2008. The diversion was still free of obstruction during the current inspection.

**4.d Hydrologic Balance: Water Monitoring**

Second quarter 2008 water monitoring is in the EDI website and has been uploaded. Water monitoring is current.

**7. Coal Mine Waste, Refuse Piles, Impoundments**

The temporary refuse pile is still under re-mining conditions. There is still the original material, segregated waste, coarse recovered and fine recovered product on the ground. The coarse and fine recovered product will be shipped and eventually will enter commerce. The remaining original waste and segregated waste will be placed back in the location of the temporary refuse pile in compacted lifts.

**18. Support Facilities, Utility Installations**

Oil storage building at the 4th east portal location is under construction. Footers, walls and saddle's have been poured. The floor is formed and ready to be poured.
