8. Noncoal Waste

March 16, 2010 is the abatement date listed on Citation 10048. The Division was notified on March 11, 2010 in the afternoon that the violation had been abated. Upon inspecting the facility on March 16, 2010 @ 10:00 am there was numerous items of non coal waste in the main parking facility and along the access road leading to the main facilities. It appears that the problem is not a climatic problem, but a personnel and policy problem. The original items were picked up in the parking lot on March 11, 2010. The items observed in the parking lot at 10:00 am were new items. The operator/permittee was given approximately four hours (2:00 pm) to bring the site into compliance to avoid a failure to abate cessation order (FTACO).

The noncoal items were removed and placed in the proper storage facilities by the end of the inspection at 2:00 pm. Citation 10048 has been terminated.
