The mine identification signs at the main facility and 4th east portal area are both located at the point of public access to the permit area and contain the required information.

4.a Hydrologic Balance: Diversions

Belting is in the diversion by the portal access road. The belting needs to be removed.

Garbage cans have been placed throughout the main parking lot. Main parking lot is free of noncoal waste items. The area shows a marked improvement from the two previous inspections.
