

1. Permits, Change, Transfer, Renewal, Sale

The current DOGM permit C/015/015 was issued effective 01/06/2006 and expires 01/08/2011.

-Certificate of Insurance policy number BOG 9377 215-06, issued 11/05/2009 and terminates 11/05/2010.

-UPDES permit UT-0022616 effective 12/01/2006 and expires @ midnight 11/30/2011.

-Air Quality permit DAQE-AN0229006-05, issued July 20, 2005.

-SPCC Plan dated 10/24/06. The Plan is P.E. certified, stamped, signed and dated by a Utah P.E.

2. Signs and Markers

The mine identification signs are in place at points of access to the permit area. The signs contain the required information.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Second quarter 2010 pond inspections were done on 06/23/2010.

4.e Hydrologic Balance: Effluent Limitations

The June 2010 discharge monitoring reports were reviewed as part of the complete inspection. The TDS loading parameter was exceeded. The company notified DEQ of the exceedance by letter.

7. Coal Mine Waste, Refuse Piles, Impoundments

The second quarter 2010 refuse pile inspection was done on 05/09/2010 and P.E. certified.

18. Support Facilities, Utility Installations

Evaluated the wind fence at the 4th East Portal area. Several sections are still loose and flapping in the wind.

20. Air Quality Permit

The Air Quality Permit Approval Order DAQE-AN0229006-05 was issued on July 20, 2005. The permit remains effective.

21. Bonding and Insurance

Bond #188617 December 3, 2008 is \$3,510,000.
