2. Signs and Markers

Mine identification signs are present at the main facility and the 4th east portal facility. Signs are located at a point of contact for the public to the permit area. The signs contained the required information.

8. Noncoal Waste

Minor amount of noncoal waste was observed. Garbage can had tipped over from high winds. Marked improvement in noncoal waste management from previous inspection.

18. Support Facilities, Utility Installations

Three segments of wind fence were observed to have failed. These segments have been repaired in the past by using zip ties. The high winds have ripped the wind fence through the ties and unsecured the wind fence. The wind fence needs to be maintained. The three sections are located high off the ground so a man lift will be required to do the maintenance work. Peter Behling was going to check to see if any material is still available on site or if more needed to be ordered. Repairs by replacement have been made to several areas on the lower tiers.

2. Signs and Markers

Mine identification sign is located to the side and at the end of the public road. Sign is placed at access into the permit area. The sign contained the required information.

4.c Hydrologic Balance: Other Sediment Control Measures

Checked the silt fence directly South East of the mine identification sign. The silt fence is still functional.
