## **2. Signs and Markers**

The mine identification signs at the main facility and at the 4th East Portal area are in place at points of contact from public access into the permit area. The signs contained the required information.

### **4.a Hydrologic Balance: Diversions**

Divrsion downstream of refuse pile access road and culvert needs to be cleaned to prevent culvert from plugging.

## **8. Noncoal Waste**

High winds the end of last week and through the weekend had spread noncoal waste around the main facility from the dumpster. The problem was identified by the operator at the beginning of the inspection. The material was removed and towed prior to the inspection. A few items were identified during the inspection that were missed in the cleanup of the site.

Buckets were observed in the diversion behind the oil storage building at the 4th East Portal area during the inspection. These items were noted and scheduled to be retrieved immediately following the inspection.
