2. Signs and Markers

The mine identifications located at the Main Facility and the 4th East Portal Facility were observed during the partial inspection. Both signs contained the required information as required by regulation.

7. Coal Mine Waste, Refuse Piles, Impoundments

All observed surface facilities were free of transient noncoal waste.
