2. Signs and Markers

The mine identification signs located at the Emery Mine main facility and the 4th East Portal area were checked as part of the complete inspection. Both signs were found to contain the name of the mine, mailing address, phone number and the Utah Mining Permit Number. The signs are in compliance with the R645 Utah Coal Rules.

5. Explosives

Powder and cap magazines are still in place. The magazines are still grounded and signed. All explosive materials has been removed from the Emery Deep Mine Site.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile is stable. No visible hazards were observed.

8. Noncoal Waste

No noncoal waste items were observed outside of the approved noncoal waste containment facilities.
