

**2. Signs and Markers**

The mine identification sign at the main facility was observed upon entrance into the mining permit area. The signs contained the name, address, phone number and Utah Mining Permit number for the Emery Deep Mine. The sign meets the Utah Coal Rule requirements.

**14. Subsidence Control**

The subsidence areas above the 00 North Section of the Emery Deep Mine were observed as part of the partial inspection. The land owner in this area is Consolidated Coal the same entity as owner and operator of the mine site.

Six sites are in this area and have been monitored in the past. The mine plans to re-institute monitoring in this area on a more frequent basis and in coordination with this the minimal surface cracking around the depressions has been roughened and filled. The information of their efforts will be included in their annual report.
