**2. Signs and Markers**

During the partial inspection both mine identification signs were checked for compliance with the Utah R645 Coal Rules. The signs checked are located at the Main Facility and the 4th East Portal area. Both signs inspected contained all of the required information.

**4.a Hydrologic Balance: Diversions**

Several diversions were checked and found to be functional. Refuse pile diversions and 4th East Diversions.
