### Assignment of Federal Coal Lease Approved

On April 28, 2014, CONSOL Mining Company, LLC, submitted an assignment of Federal coal lease UTU-86038 with Consolidation Coal Company, as assignor, and CONSOL Mining Company LLC, as assignee.

Satisfactory evidence of the qualifications and holdings of CONSOL Mining Company, LLC, has been filed, as required pursuant to the regulations at 43 CFR 3472. The Department of Justice has been forwarded information as to whether this transfer would create a situation inconsistent with the antitrust laws and no comments were received within the 30-day period. Therefore, the assignment meets the requirements of the regulations and is hereby approved effective May 1, 2015. Approval of the assignment does not constitute approval of any of the terms therein which may be in violation of the lease terms.

A rider to the lease bond No. 6656960, that is maintained in this office, in the amount of \$201,000 for coal lease UTU-86038, was filed on April 16, 2015. The rider changes the name of the principal for this bond from Consolidation Coal Company to CONSOL Mining Company, LLC, a subsidiary of CONSOL Energy, Inc. Safeco Insurance Company of America remains the surety of this bond, covering Federal coal lease UTU-86038.

The rider has been reviewed and found acceptable as of the date of filing.
