9. Protection of Fish, Wildlife and Related Environmental Issues

The artificial burrows were installed as part of a mitigation research project to determine if Burrowing Owls would: a) nest in the burrows and or b) if second mining subsidence of approximately 4' would damage the artificial and or natural burrows located above and outside the zero zero north panel. The 7 artificial burrows were installed in 2010 and have been inventoried several times. The results were and continue to be no Owl occupancy and some prairie dog occupancy. There was dirt in every burrow that ultimately blocked access to the burrow at the end of the tunnel. Possible ways to clean the tunnels are being considered.
