2. Signs and Markers

The mine identification signs at the main facilities and the fourth East facilities were checked. Both locations had the signs posted before entrance into the permit area. Both signs contained all of the required information set forth as requirements in the Coal Rules.

4.a Hydrologic Balance: Diversions

Several road diversions were checked at the main facility and fourth East Portal area. The diversions that were checked were functional. Not all diversions associated with this permit were inspected.

5. Explosives

No explosives and/or magazines are on the mine site.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile is stable. No visual hazards were observed.
